It has tusks like a mammoth, but they are shorter and curve only slightly. They also like to eat grass and sugarcane. Asian elephants live in Southeast Asia.

The woolly mammoth died out 10,000 years ago. As oceans rose, the mammoth's habitat disappeared. Therefore, the mammoth had a difficult time finding food. The mammoths died out in great numbers 10,000 years ago.

Scientists have studied mammoths for a long time. Maybe they will learn why the woolly mammoth disappeared.

SUPPORTING PARAGRAPHS The third paragraph talks about Asian elephants. Does this information support the main idea?

CONCLUSION The conclusion does not really summarize the main idea of the text. How could the main idea be better summed up?
